TERMS AND CONDITIONS OF ENTRY – MEMBERSHIP APPLICATION – INDEMNITY FORM

RACING HYPE PTY LTD (A.C.N. 112 162 320) whose registered office is situated at 734 Main Road, Eltham Victoria 3095 (herein after called "Gold Coast Indoor Hire Karts") agrees to hire to the Hirer whose name, address and signature appears below and to permit the Hirer to use the karts, services and facilities upon the terms and conditions herein after appearing. The Hirer:-

- 1. Agrees that the driving of go-karts is inherently dangerous and may lead to either death or injury. The Hirer voluntarily agrees to accept all risks and danger, prior to, during and subsequent to the driving of go-karts, including damage or injury caused by other drivers.
2. Agrees to use Gold Coast Indoor Hire Karts services and facilities or occupy the premises and surrounds of 95 Spencer Road, Nerang, and any part of it at their own risk and release to the full extent permitted by law, Gold Coast Indoor Hire Karts, and its staff, agents, invitees and licensees of Gold Coast Indoor Hire Karts and each of them from all liabilities whatsoever arising (including but not limited to any negligence or breach of control) resulting from any accident, loss, damage or injury to the hirer or its staff agents, sub-contractors, invitees, licensees or permittees.
3. The Hirer by this agreement indemnifies Gold Coast Indoor Hire Karts and agrees to keep Gold Coast Indoor Hire Karts always indemnified in respect of all loss, damage, consequent loss and damage claimed by any person against Gold Coast Indoor Hire Karts and legal fees or consultants fees which Gold Coast Indoor Hire Karts may suffer or incur and all money which Gold Coast Indoor Hire Karts may become liable to pay any person in respect of or arising directly or indirectly out of any act, default or omission on the part of the Hirer or its his or her employees, servant, agents, invitees, licensees and / or permittees.
4. Agrees to abide by the rules and regulations established by Gold Coast Indoor Hire Karts from time regarding the use and facilities and services of Gold Coast Indoor Hire Karts and shall comply with all lawful directions of Gold Coast Indoor Hire Karts as are given from time to time.
5. Grants permission to Gold Coast Indoor Hire Karts and their agents to utilise the Hirers image or likeness incidental to any photographic record live or recorded video display or any other transmission or reproduction in whole or in part, in any way which Gold Coast Indoor Hire Karts or such authorised person sees fit.
